**[III] EDUCATIONAL QUALIFICATIONS:**

Minimum Educational Qualifications, Experience and Publication etc. for all the posts shall be applicable as prescribed by the 'UGC REGULATIONS ON MINIMUM QUALIFICATIONS FOR APPOINTMENT OF TEACHERS AND OTHER ACADEMIC STAFF IN UNIVERSITIES AND COLLEGES AND MEASURES FOR THE MAINTENANCE OF STANDARDS IN HIGHER EDUCATION, 2018', University Rules and concerned statutory bodies as amended from time to time.

**[IV] RELAXATION:**

A relaxation of 5% shall be allowed at the Bachelor's as well as at the Master's level for the candidates belonging to Scheduled Caste/Scheduled Tribe/Other Backward Classes (OBC)(Non-creamy Layer)/Differently abled ((a) Blindness and low vision; (b) Deaf and Hard of Hearing; (c) Locomotor disability including cerebral palsy, leprosy cured, dwarfism, acid-attack victims and muscular dystrophy; (d) Autism, intellectual disability, specific learning disability and mental illness; (e) Multiple disabilities from amongst persons under (a) to (d) including deaf-blindness) for the purpose of eligibility and assessing good academic record for direct recruitment. The eligibility marks of 55% marks (or an equivalent grade in a point scale wherever the grading system is followed) and the relaxation of 5% to the categories mentioned above are permissible, based only on the qualifying marks without including any grace mark procedure.



**[V] Eligibility**

**(A) For the Disciplines of Arts, Commerce, Humanities, Social Sciences, Sciences, Languages, Library Science**

**(i) Professor:**

**Eligibility: (A or B)**

- A. i) An eminent scholar having a Ph.D. degree in the concerned/allied/relevant discipline, and published work of high quality, actively engaged in research with evidence of published work with, a minimum of 10 research publications in the peer-reviewed or UGC-listed journals and a total research score of One Hundred Twenty (120) as per the criteria given in Appendix II, Table 2 ( As per UGC Gazette dated 18 July 2018)
- ii) A minimum of ten years of teaching experience in university/college as Assistant Professor/ Associate Professor/Professor, and / or research experience at equivalent level at the University/ National Level Institutions with evidence of having successfully guided doctoral candidate.

**OR**

- B. An outstanding professional, having a Ph.D. degree in the relevant/allied/applied disciplines, from any academic institutions (not included in A above) / industry, who has made significant contribution to the knowledge in the concerned/allied/relevant discipline, supported by documentary evidence provided he/she has ten years' experience.

**(ii) Associate Professor:**

**Eligibility:**

- i) A good academic record, with a Ph.D. Degree in the concerned/allied/relevant disciplines.
- ii) A Master's Degree with at least 55% marks (or an equivalent grade in a point-scale, wherever the grading system is followed).
- iii) A minimum of eight years of experience of teaching and / or research in an academic/research position equivalent to that of Assistant Professor in a University, College or Accredited Research Institution/industry with a minimum of seven (7) publications in the peer-reviewed or UGC-listed journals and a total research score of Seventy-five (75) as per the criteria given in Appendix II, Table 2 (As per UGC Gazette dated 18 July 2018)

**(iii) Assistant Professor:**

**Eligibility: (A or B)**

- A i) A Master 's degree with 55% marks (or an equivalent grade in a point-scale wherever the grading system is followed) in a concerned/relevant/allied subject from an Indian University, or an equivalent degree from an accredited foreign university



- ii) Besides fulfilling the above qualifications, the candidate must have cleared the National Eligibility Test (NET) conducted by the UGC or the CSIR, or a similar test accredited by the UGC, like GSLET/GSET or who are or have been awarded a Ph. D. Degree in accordance with the University Grants Commission (Minimum Standards and Procedure for Award of M. Phil. /Ph.D. Degree) Regulations, 2009 or 2016 and their amendments from time to time as the case may be exempted from NET/GSLET/GSET :

Provided, the candidates registered for the Ph.D. programme prior to July 11, 2009, shall be governed by the provisions of the then existing Ordinances/ Bye-laws/Regulations of the Institution awarding the degree and such Ph.D. candidates shall be exempted from the requirement of NET/GSLET/GSET for recruitment and appointment of Assistant Professor or equivalent positions in Universities/ Colleges/Institutions subject to the fulfillment of the following conditions: -

- a) The Ph.D. degree of the candidate has been awarded in a regular mode;
- b) The Ph.D. thesis has been evaluated by at least two external examiners;
- c) An open Ph.D. viva voce of the candidate has been conducted;
- d) The Candidate has published two research papers from his/her Ph.D. work, out of which at least one is in a refereed journal;
- e) The candidate has presented at least two papers based on his/her Ph. D work in conferences/seminars sponsored/funded/supported by the UGC / ICSSR/ CSIR or any similar agency.

The fulfillment of these conditions is to be certified by the Registrar or the Dean (Academic Affairs) of the University concerned.

**Note:** NET/GSLET/GSET shall also not be required for such Masters Programmes in disciplines for which NET/GSLET/GSET is not conducted by the UGC, CSIR or similar test accredited by the UGC, like GSLET/GSET.

**OR**

- B.** The Ph. D degree has been obtained from a foreign university/institution with a ranking among top 500 in the World University Ranking (at any time) by any one of the following: (i) Quacquarelli Symonds (QS) (ii) The Times Higher Education (THE) or (iii) the Academic Ranking of World Universities (ARWU) of the Shanghai Jiao Tong University (Shanghai).

**Note:** The Academic score as specified in Appendix II (Table 3A) (As per UGC Gazette dated 18 July 2018) shall be considered for short-listing of the candidates for interview only, and the selections shall be based only on the performance in the interview.

**(i) Professor:**

**Eligibility: (A or B)**

- i** Ph.D. degree in the concerned / allied / relevant disciplines and First class or equivalent at either Bachelor's or Master's level in the relevant branch and at least 55% marks in Master's level (or an equivalent grade in a point-scale wherever the grading system is followed),
- ii** Minimum of 10 (ten) years of experience in teaching / research / industry out of which at least 3 (three) years shall be at a post equivalent to that of an Associate



Professor,

- iii At least 10 (ten) research publications out of which at least 7 (seven) at the level of Associate Professor in SCI journals / AICTE approved list of journals / peer-reviewed or UGC-listed journals and at least 2 (two) successful Ph.D. guided as Supervisor/Co-supervisor till the date of eligibility,
- iv Total research score of 120 (one-hundred and twenty) as per the criteria given in Appendix II, Table 2 (As per UGC Gazette dated 18 July 2018)

An outstanding professional, having a Ph.D. degree in the relevant / allied / applied disciplines, from any academic institutions (not included in A above) / industry, who has made significant contribution to the knowledge in the concerned / allied / relevant discipline, supported by documentary evidence provided he/she has 10 (ten) years' experience.

4. Applicant shall submit the application in person or by post in the prescribed form together with all enclosures in envelope superscribed "**Application for the post of "\_\_\_\_\_**" in the P.G. Department of "\_\_\_\_\_ " so as to reach the Registrar, Sardar Patel University, Vallabh Vidyanagar- 388120 on or before **30/04/2025, 5:00 p.m.** Application received after the due date will be liable to be disregarded. The University will not be responsible for postal or any delay.
5. Applicants are advised to submit the applications to the University well in advance without waiting for the last date to avoid postal delay or any delay due to other unforeseen events or circumstances. The University will not be responsible for any postal delay or any delay at any stage. Applications received after the last date and time mentioned above will be rejected.
6. The candidate having necessary medical certificate of disability of 40% and above shall be considered as physically disabled candidate.
7. **Persons with Disability (PwD) are required to submit the relevant Disability Certificate issued by the competent authority as per the policy of the Government of Gujarat.**
8. **Reservation for Persons with Disabilities will be as per the existing policy of Government of Gujarat, Department of Social Justice and Empowerment and its amendments from time to time till the last date of receiving application.**
9. Applicants who are already in service should forward printed copy of online filled application form (hard copy) through proper channel. Direct application will not be considered. However, such a candidate can send in advance, one copy of online application form, so as to reach before the deadline. Such an application will be deemed in time, provided the hard copy of application



through proper channel is forwarded before last date.

If the original application through proper channel has not been received by the University till the last date mentioned in this employment notification, the applicants will have to submit a 'NO OBJECTION CERTIFICATE' from his/her employer to the University at the time of interview.

36. Any additional qualifications, experience, number of papers published, honours and other achievements gained by the candidate during the period between the last date of application and the date of conducting the interview shall not be taken into consideration.
37. To arrive at appropriate Research Score, the evidences towards the claims must be provided as enclosures in the same order of the claim made.
- (a) Photocopy of research paper from which nature of journal (National/ International etc) can be decided.
  - (b) Appropriate evidence of impact factor of the journal during the period of publication of your paper/article.
  - (c) Certificate of Conference/Work Shops/Seminar/Course/Program mentioning clearly paper presentation/ invited talk and its nature (National, International etc)
  - (d) Photocopy of first few pages of Conference proceedings / book/ chapters in book showing clearly ISBN/ Authors/ Publishers/ Year of Publication, place of conference nature (International/National/State/University) of conference and other essential data.
